14. Participants must be aware of posted pool rules at all times, including but not limited to pool rules.
15. No large inflatable items allowed in the pool. YMCA provides noodles and life jackets, for your convenience.
16. All swimmers will need to take "Past the test to lose the vest", with lifeguard.
17. Swim first hour, then party room. NO EXCEPTIONS. Failure to vacate the premises on scheduled time, will result in loss of deposit.

**Facility Agreement/Liability Waiver**

By signing below indicates that you have read, understand, and agree to the rules listed above. By my signature and my free will I do hereby agree to indemnify and save harmless the YMCA of Abilene from any and all claims or demands, cost or expense arising out of any injuries or damages sustained by me or any party to or from who I am responsible. Failure to comply with the YMCA rules and policies may result in participants being asked to leave the YMCA. In the event of pool closure, you have the choice to (pick one) reschedule for another date, receive a refund, or use other areas approved by the YMCA (Gym, small gym, etc.). I am an adult over 18 years of age and wish to participate in YMCA of Abilene ("YMCA") activities. In addition, I give my children permission to participate in YMCA of Abilene Activities. I understand that even when every reasonable precaution is taken, accidents can sometimes happen. Therefore, in exchange for the YMCA allowing me to participate in YMCA activities, I understand and expressly acknowledge that I release the YMCA of Abilene and its staff members from all liability for any injury, loss, or damage connected in any way whatsoever to my (or my children's) participation in YMCA activities, whether on or off YMCA's premises. I understand that this release includes any claims based on negligence, action or inaction of the YMCA of Abilene, its staff, directors, members and guests. I have read and am voluntarily signing this authorization and release. I understand that the YMCA of Abilene is not responsible for personal property lost or stolen while members and/or program swim participants are using the YMCA facilities or are on YMCA premises. I give permission to the YMCA of Abilene to use limitation and obligation, photographs, film footage, or tape recordings which may include my image or voice for purposes of promoting YMCA Programs.

I understand that anyone under the age of 13 has to be supervised by someone older than the age of 18 at all times while in the facility.
